TRAINING FOR LAY LEADERS

FACT SHEET FOR CONGREGATIONAL COMMUNICATION OFFICERS AND CONGREGATIONAL SECRETARIES

WHAT IS THE NEW INITIATIVE?

The UCJCI Training for Lay Leaders. This training incorporates the previous training for elders and lay pastors with the added component of opening up the training to leaders of special ministries in the church e.g. youth, outreach, evangelism, children's ministries, community development etc.

WHAT WILL THE TRAINING INVOLVE?

The Training will be conducted in three modules.

- Missional Leadership with Children and UCJCI Child Protection Policy
- Missional Leadership with Youth
- Missional Leadership with Specialized groups (Men, Women, etc.) and Frontier Ministries (among persons who are marginalized and considered outcasts)
- Missional Leadership in Community
- Basic Homiletics

The course content will be delivered in class sessions, through assignments and class presentations. It is anticipated that some courses will eventually be developed through webinars (seminars on the internet).

WHO SHOULD DO THE TRAINING?

Module 1 is compulsory for all persons undertaking the training. Modules 1 and 2 are requirement for persons desiring to serve as leaders in specialized ministries. Modules 1, 2 and 3 are requirements for persons desiring to serve as Lay Pastors.

ARE ALL ELDERS AND LAY PASTORS REQUIRED TO DO THE TRAINING?

All newly elected elders as of 2020 are required to do the first module of the training. All persons aspiring to be Lay Pastors are required to do all three modules of the training.

WHY HAS UCJCI RE-DESIGNED THE LAY TRAINING?

Training has been conducted in all regions over the years, but the course content is not standardized and therefore not adequately quality assured. In this re-designed approach all persons who undertake training will receive specific common training so the work may be certified.

WHO WILL CERTIFY THE TRAINING?

The Training will be certified by the International University of the Caribbean.

HOW OFTEN WILL TRAINING BE DONE?

Two sessions will be held each month. Regional Mission Centres will specify. The following are start periods for each region
