ADVISORY #23 TO: UCJCI MINISTERS, LAY PASTORS AND CONGREGATIONAL BOARDS RE: COVID-19 CORONAVIRUS PANDEMIC

My sisters and brothers,

Greetings,

The UCJCI COVID-19 Response Team now meets every two weeks. Consequently, these updates will follow the scheduled meetings.

Following are the reminders and decisions taken by the Team, which met yesterday, September 1, 2020, under the various headings. **New/updated information is in bold print.**

1. Compliance with National Orders/Protocols

We celebrate the fact that Cayman is now COVID-19 free. Consequently, masks are no longer mandatory although social distancing rules remain in place. Schools have resumed using the inclass model with no remote learning.

In Jamaica, we continue to see a significant spike in the number of persons who have contracted the disease, combined with a fall in the recovery rate, which currently stands at 44.2%. It is clear given the number of cases under investigation that there is community spread across the island.

We continue to encourage compliance with the directives and recommendations of the legitimate state authorities in both nations.

2. Congregational Life

Church Worship

- Most of the United Churches in Cayman have resumed services in their sanctuaries.
- The church in Jamaica is allowed to gather for worship under a number of conditions. We have, however, received reports that in some cases, persons have not been following some of the protocols, including the wearing of masks and physical distancing. Given the recent spike in confirmed cases, we strongly urge you to ensure that all of the following conditions are met for Sunday worship in your congregation(s):

- Distancing rule of one person per 40 sq. ft., with persons being at least 6 feet apart. All persons are required to observe the physical distancing rule, however, families can sit together.
- Outside of the sanctuary, all gatherings are limited to 20 persons under physical distancing rules.
- Have multiple services. (The same persons should not be present in multiple services.)
- We recommend that a record of the persons attending the service, including their contact number, be kept in order to assist the health authorities in their contact tracing process, in the event of a confirmed case among attendees.
- Temperature checks prior to entering the sanctuary. We strongly recommend the use of infrared thermometers.
- Ensure sanitization measures are in place at entrances.
- All persons must wear a mask.
- Choirs are not allowed.
- Air conditioning units are not to be used in the sanctuary.
- The Stay-at-Home Order applies to persons aged 75 years and over. All our lay pastors and retired ministers within this age range are required to abide by this rule and should engage their congregation or charge remotely. Your Regional Mission Council will be in touch with you to assist, where possible, in facilitating remote services and meetings.
- The expectation of the health authorities is that the cases in Jamaica will continue to rise for the next 6 weeks. In order to safeguard the health of our members and adherents our expectation is that you will ensure that these guidelines are strictly enforced.
- We strongly suggest that gatherings, outside of worship (meetings, bible studies etc.), be held remotely to minimize in person contact and so limit the spread of the disease.
- Funeral Services are not allowed at this time. Burials are permitted with a maximum of 15 persons including, the pastor, family members and cemetery/grave personnel.
- We encourage you during this period to include in your worship services, prayers and other expressions of solidarity with members and adherents who have suffered recent bereavement, including those due to COVID-19.
- Based on the social distancing rules, coupled with the warning from the state authorities of the spike in the number of confirmed cases, we do not endorse adult baptism at this time. However, we will be engaging our congregations in a time of reflection on the theology of baptism and conversations on the practices of baptism in light of COVID-19.
- We encourage the continuation of streamed services and sharing on social media, as some persons will still not be able to attend worship services.
- We remind you of the time of prayer every Wednesday between 12 p.m. and 1 p.m. We will share with you the specific suggested foci for each week. Please remember our first responders, especially our health practitioners, during these stressful times.
- We continue to distribute the weekly House Worship Liturgy, using a thematic approach with sermon/reflection notes. We welcome feedback on how this is being used within the church.
- Tune in each Sunday to LOVE 101 FM in Jamaica at 3:30 p.m. for a rebroadcast of a congregational worship service or the sharing of reflections or activities by the UCJCI.

3. **Pastoral Care**

- Given the psychological impact of the restriction of movement caused by the coronavirus, we celebrate those persons who continue to call members and offer inspirational messages and other support systems. Regional Counsellors have been appointed, and this ministry is available in all regions.
- We continue to encourage congregations and regions to be especially sensitive to the needs of the elderly. Please ensure that their basic needs are met (food, sanitization, medication) and, where possible, offer daily contact by phone or social media to those who live alone.
- We also encourage you to engage your congregants to determine their access to, and understanding of, the digital space in order to gauge our reach as a church.

4. **Regional Council Meetings**

All regions in Jamaica will conduct their Council Meetings, scheduled for September 2020, remotely.

5. **Synod and Regional Offices**

In an effort to mitigate any risk of Covid-19 infection among staff while maximizing productivity, please note the following which will guide our operations until September 8, 2020:

The Synod Administrative Centre and each Regional Office (Jamaica) will open for 2 days per week, 9 a.m. to 3 p.m.:

- **Output** Synod Administration Centre Mondays and Thursdays
- WRMC Mondays and Thursdays
- o SRMC Mondays and Thursdays
- NERMC Tuesdays and Thursdays

The Cayman Regional Office will operate its normal working days and hours.

6. Communication

Please continue to pay close attention to the various pieces of information sent to you via our communication channels (radio, e-mail, website [www.ucjci.com], WhatsApp Messenger, Twitter, Instagram and Facebook).

May we together continue to depend on God, who has not given us a spirit of fear, but of love and of power and of a sound mind (2 Timothy 1:7).
