he Council for World Mission is a partnership of Christian churches with thirty-two members across the world representing some 21 million Christians in 40 countries. Together, these members commit to sharing their resources of money, people, skills and insights globally to carry

out God's mission in local spaces. The nexus of partnership sharing is the mission of God. The aspirations of this family of churches is captured in the vision statement, "Life-flourishing communities, living out God's promise of a New Heaven and a New Earth."

The history of CWM is combined in the endeavours of the London Missionary Society, the Commonwealth Missionary Society and the (English) Presbyterian Board of Mission which were incorporated into CWM in 1977.

CWM, as an organization, is driven to achieve the

'not yet' of a world where God's creation is sustained and this is seen in life-flourishing communities. This partnership of churches in mission understands its purpose as 'to further the work of Christian mission throughout the world'.

Throughout the years CWM member churches have been encouraged to discern the signs of the times in the global environment and read their contexts in order to be alert to needs and to respond creatively appropriately seeking partnership with others who share the vision of fullness of life. Fullness of life may be evidenced through bold faith and action working towards life-flourishing economy, education, evangelism and creation. UCJCI has played its part alongside other member churches. UCJCI members have participated in the leadership and governance of CWM as staff and Board members. Members of UCJCI have participated in CWM programmes and initiatives including Training in Mission and other youth programmes; consultations, conferences and mission experiences for men and women, ordained and lay persons which promote study, witness and provide stimulation for discerning emerging mission issues and developing appropriate responses through collaboration and training. UCJCI has also hosted events and provided the context of learning for programmes such as A New Face, Young Women Enabling Transformation and Training in Mission.

There are six CWM regions and UCJCI and Guyana Congregational Union are members of CWM Caribbean.

The region's office is located in Jamaica in the Synod Administrative Centre. The region is staffed by a Mission Secretary for Europe and the Caribbean - Rev. Dr. Michael Jaggesar and Programme Associate - Mrs. Vickeisha King Burke.

Among the programmes and events organized by CWM Caribbean is the Member Mission Forum (MMF) held May 18 and 19, 2021.

The MMF is intended to be a space where member church delegates affirm, peer assess, discern, and plan their engagements in mission. It is resourced and facilitated by CWM's regional staff for the member churches to be informed, energised, and empowered to act. The MMF allows member churches to HEAR; H – Hear from each other in regions, across regions and ecumenically; E – Evaluate how they have been engaging in mission and peer-assess how it may be done differently to advance the church's vision; A – Act and mobilise teams towards mission development; and R - Reflect together on matters that deal with God's mission in the light of social, economic, political issues.

"Breathe life into dead and dying situations", that was the resounding call at the Members' Mission Forum 2021 which was held under the theme, 'Rise to Life: Confessing witness to life flourishing communities.' The programme was enriched through worship sessions, theme reflection, responsive context reading, creative input from artist, musicians and poets, and virtual exposure visits.

### A PARTNERSHIP WORTH CELEBRATING

We celebrate and affirm that the UCJCI's membership within the CWM family continues to significantly reflect CWM's mandate of sharing resources of people, ideas and money.

#### **Sharing Resources**

The UCJCI's strategic direction over the last two decades has seen the implementation of major strategic programmes, including the current **Renewal and Transformation** agenda, funded largely through CWM's **Mission Support Programmes (MSP)**. These have included, among others, training and development, resource materials and children and youth ministries.

The training and development of personnel, the support for a mission enabler and the procurement of Information Technology resources are but a few of the ways we have benefitted from CWM's **Member Church Initiative** (MCI).

A number of our ministers and administrative staff have been supported in their academic pursuits through scholarships granted through CWM's **Academic Accompaniment programmes**.

Our young people, seminarians, ministers, pastors and members have been offered exposure and vocational development through a raft of programmes, including, **Training for Mission; Young Women Enabling Transformation, Face to Face; A New Face and Face the Facts.** 

#### **Sharing Ideas**

We celebrate the richness of our participation in, and contributions to, the sharing of ideas. These have been manifested through a number of local and global consultations around the issues of children, women, men, the environment, gender justice, poverty alleviation and slavery and reparation.

### **Sharing People**

Perhaps the pinnacle of our celebrations continues to be the sharing of people through the **Partners in Mission**  **Programme (PIM)** both as a sending and a receiving church. The measure of the positive impact upon our ministry and mission as a church in both nations through those who have shared in our ministries and the contributions of some of our most gifted people to other member churches within the CWM family cannot be quantified.

We celebrate the gift of solid and effective leadership offered by UCJCI members to the governance and administration of CWM. This has been and continues to be evidenced, in our presence in the secretariat, the regional offices, the Board of Governors, the various strategic, programmatic, evaluation, and events planning committees.

There is little doubt that our partnership with CWM is one worthy of celebration as together we continue to pursue the vision of "Life-flourishing Communities, living out God's promise of a New Heaven and a New Earth."

## **CWM PARTNERS IN MISSION WORK ALONGSIDE UCJCI**

#### **REV. JANE KALUBA—United Church in Zambia**



My name is Jane Chingandu Kaluba and I came to Jamaica with my niece, Suwilanji Mwansa in August 2017 to work and share the good news of Jesus Christ with UCJCI in Jamaica in partnership with Council for World Mission.

God takes his people to different places across boundaries and across cultures reminding them that Jesus is a boundary breaker. I came to this place to be a truth teller as someone has said, "Genuine hope is not blind optimism, it is hope with open eyes which sees the suffering and yet believes in the future." It is now close to four years in Jamaica and it has been a time for pastoral work and community outreach. The community of faith, namely the Immanuel/Boscobel charge, has enabled the members and I to grow together in our spiritual lives as space and

support were given for the gifts of God to be exercised as we allowed Jesus to lead the church. We have shared in the struggles, celebrations and sorrows as a community especially in the time of COVID 19. Our care for each other as we share the bible studies on virtual space

has made us realise that things will never go back to the old way of doing ministry. This has made the church wake up reminding us, as John Wesley said, 'the world is my Parish' that the building is not the church. The church is in the hearts of people and Jesus leads the church and the community of faith has to follow Jesus to reach the hearts of people. We have also learnt that we need each other more than ever with relationships bound in love.

Being a Partner in the worldwide Mission of God is something that I have come to treasure because our lives have been exposed to different approaches to ministry in different contexts. God has taught me things I would have taken for granted in my own country and the community of faith has come to appreciate that God can call and use anyone no matter where they come from. I have learnt that the gospel is the same yesterday today and forever, only contexts and situations change. I have

learnt that the gospel does not revolve around one group of people, but that there are different applications and contexts for applying the gospel As one man of God said, "Do not stop following the Spirit; do not fuss about the numbers seated in the pews. Talk about people that are being touched by the gospel in the virtual space and in your congregation." We will keep on walking together with UCJCI and CWM and testifying about people that are being

# **BEYOND THE PULPIT**

Professor Roderick Hewitt concludes his presentation on this troubling conflict which reflects an intersection of politics and faith.

### Fullness of Life for all

This article argues that the position taken by many Jamaican Christians and church leaders that give uncritical support to Israel's conflict with the Palestinians is untenable and against the gospel of Jesus that offers "fullness of life for all". If Israel does not regard or respect the Palestinians as human beings whose lands they occupy, as created in God's image just like the Jews and other people of the world, then neither will their human rights be respected by others whom they oppress. The full force of the Israeli government and its media allies has engaged in a systemic policy to dehumanize and demonise the Palestinians in order to legitimize the occupation of their lands.

The political, economic and military support for Israel in their historic oppression of Palestinians and the current unbalanced and violent assault on Gaza that has killed over 1,900 people, most of whom are civilians, is an untenable and morally repugnant situation. Church leaders must therefore be willing to ask uncomfortable questions about what is going on in Palestine and to use the lens of the God of life, justice, peace and love that is revealed in the ministry and mission of Jesus to take a stand. This should not be determined by the political agenda of powerful religious conservative and fundamentalist lobby groups that influence the USA policy towards Israel.

#### The land of Palestine was never unoccupied

These fundamentalist evangelical Christians have promoted the myth that the land of Palestine was unoccupied when the Zionists occupied it in 1948. This is so far from the truth. Palestine has remained consistently occupied by Palestinian Christians and Muslims and other indigenous Arabs and Jewish communities from the time of the Romans through to the end of the Ottoman Empire when the British took control of the area. Therefore any solution of the situation must be a win-win for both Jews and Palestinians.

We must not be tricked into accepting that Israel is fighting for its survival from hostile enemies, as it loves to claim. Neither Hamas nor any other State in the Middle East has the necessary military resource capacity to defeat Israel, which has the fourth largest army in the world that is outfitted by the USA and Europe. It is Israel's policy towards the Palestinians that

has created Hamas, whose despicable acts of kidnapping Israeli civilians and firing missiles on their cities are evil actions born out of desperation and hopelessness. The equation must be changed and it can only come from groups that can influence Israeli-American policy.

When one considers the economic cost of the war in Gaza one can see the inhumanity that has pushed the already battered and besieged economy many years into the doldrums. When one compares the Palestinian condition with Israel getting over \$2billion in aid from the USA each year, it becomes clear that there exist little incentives for Israel to make peace with Palestine. The actions of Israel with the Palestinians suggest that they are using apartheid policies that were perfected in South Africa to construct separate development for the Palestinians that they demonize and make second class humans as they seize their lands.


### What can we do?

The Jamaica Government and people that included many conservative evangelical Church leaders took a stand against South African apartheid policies that belittled the human dignity of Africans. A similar case exists with the Palestinian people that demand all Jamaican people of goodwill to take a stand. Therefore, the only peaceful form of resistance open to Jamaican Christians that value peace with justice for the Israeli and Palestinian people would be to lobby for boycott of companies that support Israeli government military polices and machinery, divestment of all forms of Jamaican trade with Israel and to network with other groups around the world that are advocating equal rights and justice for both Palestinians and Israelis.

The only just way forward is a two state solution where each nation lives in mutual respect for each other. We need to march and protest and make our voices heard. We must educate our people, especially church leaders who misuse scripture to give uncritical support to Israel. They may be sincere in their belief,

but they are sincerely wrong. The God of Israel is also the God of the Palestinians. This God of life, seen in the life and work of Jesus Christ, has no favourites, but will consistently defend victims who are oppressed by the powerful of this world (John 10:10).



## Guidelines for Congregations and Councils

Jamaica and Cayman are currently in the Atlantic hurricane season. The CIRMC produced guidelines to aid preparedness and the details will be shared in Update in the coming weeks.

#### **GENERAL CARE AND OVERSIGHT**

Therefore, on an ongoing basis, Congregations should implement a structure and arrangements to ensure attention to the following:

The <u>full list of all Members and Adherents</u> is reviewed and a 'needs assessment' completed for each person. Where special needs, such as those listed below, are identified, then arrangements, as follows, should be made and implemented. (This procedure will require regular, planned updating.)

1. <u>Persons living alone are checked on daily by someone</u> – where there are family members or neighbours who do this faithfully, there may be no need for the Church membership to do so, but simply to let the individual and the relative/neighbour know that we are available to help and who to contact. Depending on the circumstances, the question may also need to be asked whether the person should continue living alone.

2. Special arrangements for similar oversight may also be needed where more than one <u>elderly person live together</u>, and to ensure proper taking of medication, meals, etc.

3. Especially when there are no close, younger relatives involved, the Congregation will want to ensure that the living quarters of such persons are properly outfitted with sanitary and safety equipment, etc.

4. Such 'alone' persons should also be visited more regularly, on a planned basis, by the Congregation, as well as the carefully planned contact by the Minister and members in the spirit of friendship and love providing COVID 19 protocols can be observed.

5. <u>Persons with young children</u> also need to be given special consideration in our planned ministries of care and support. The number of children may be a factor, or the income level of the parent(s), the health considerations, and whether there are two parents or only one, and the level of 'grandparent' and other family support.

6. Depending on the circumstances of the household (e.g. age and income level), the Church should be alert to fire hazards and, where possible, discuss safety equipment such as fire/ smoke detector alarms and fire extinguishers, and check that the individuals know how to use them.

<u>Consideration must also be given to the situation of nonnationals living in Jamaica</u> – do they have any family or a friends-network already established?
